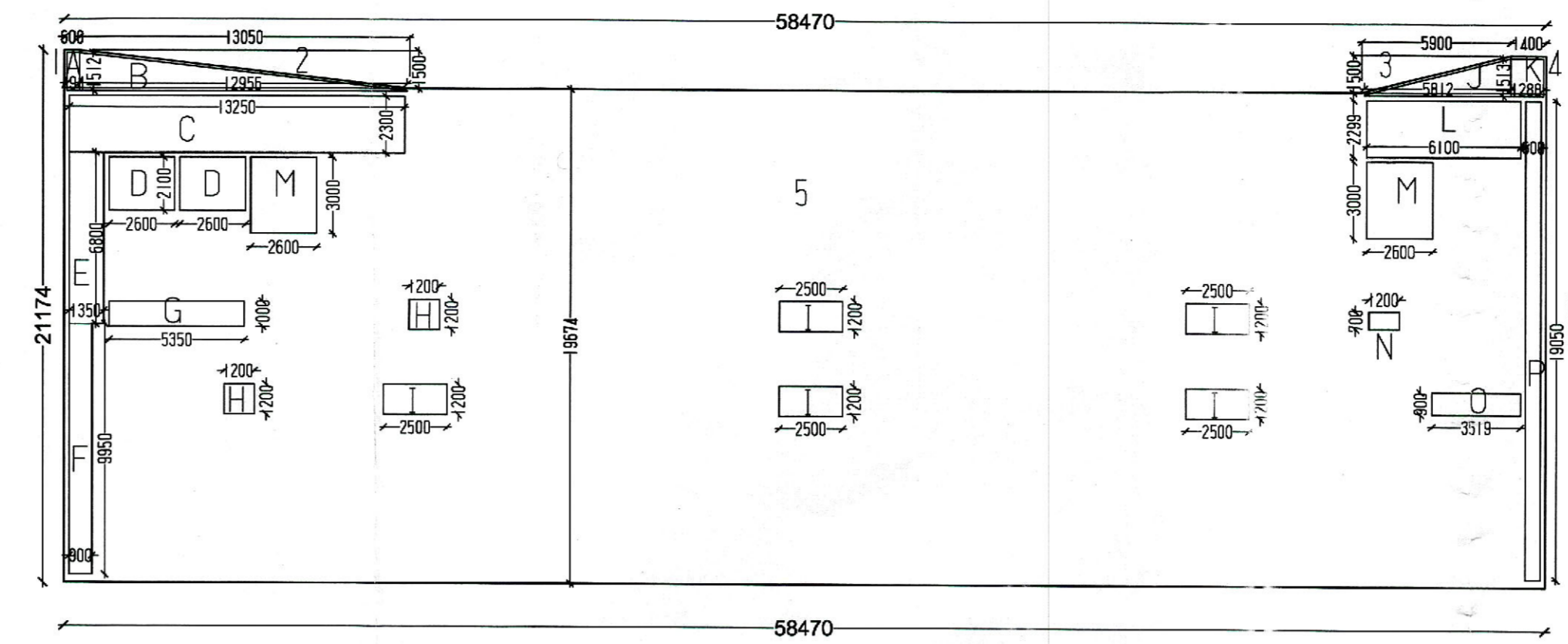

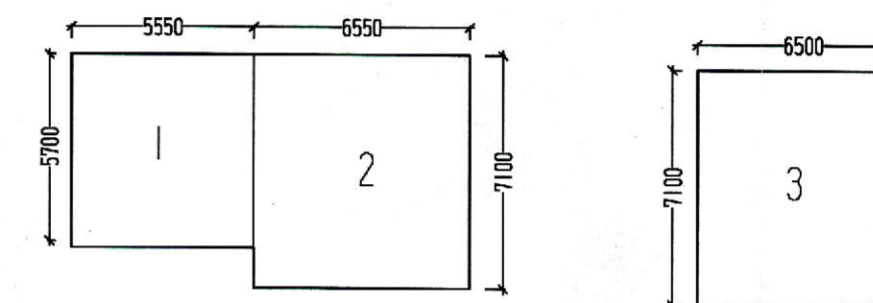
5TH FLOOR PLAN

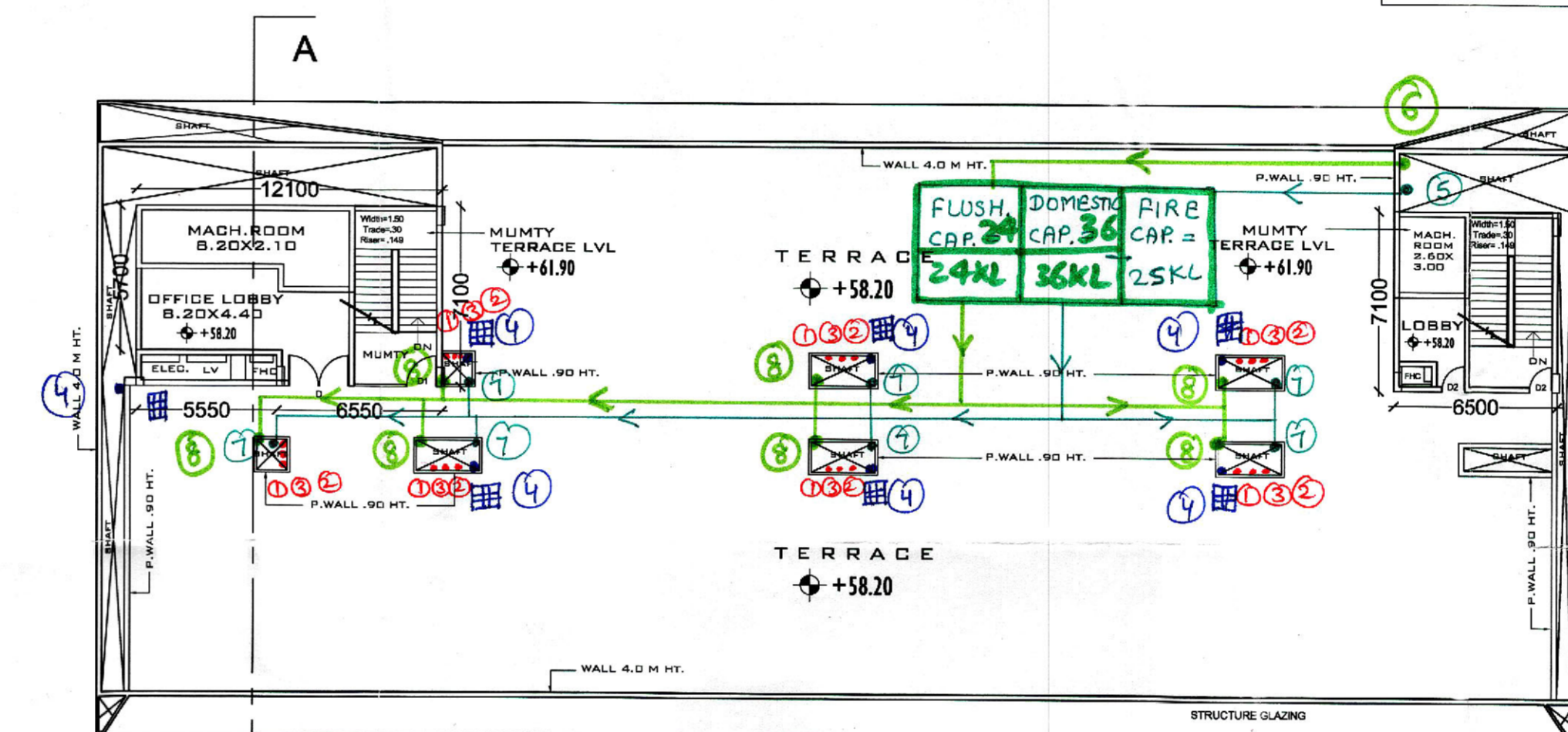

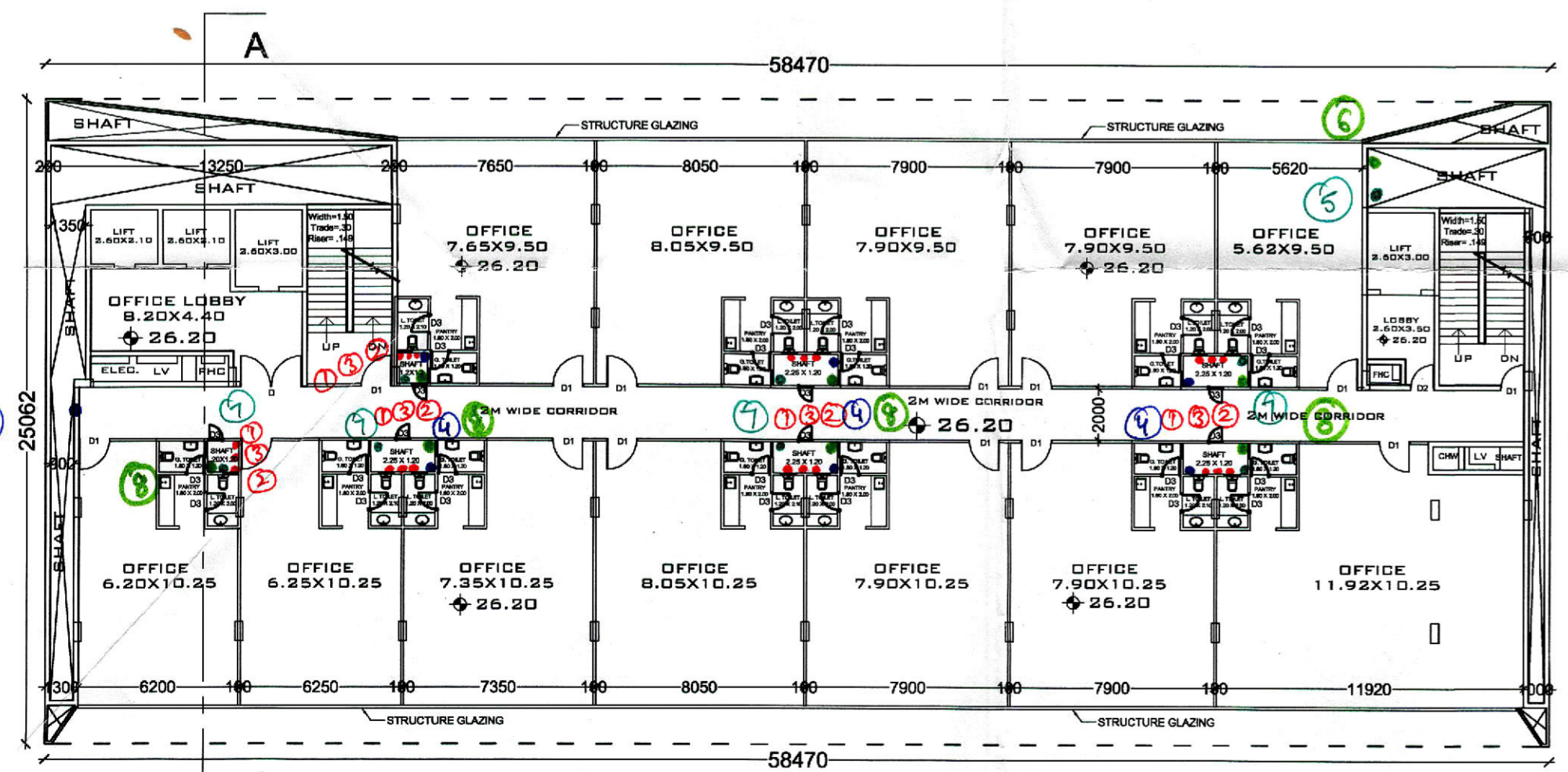

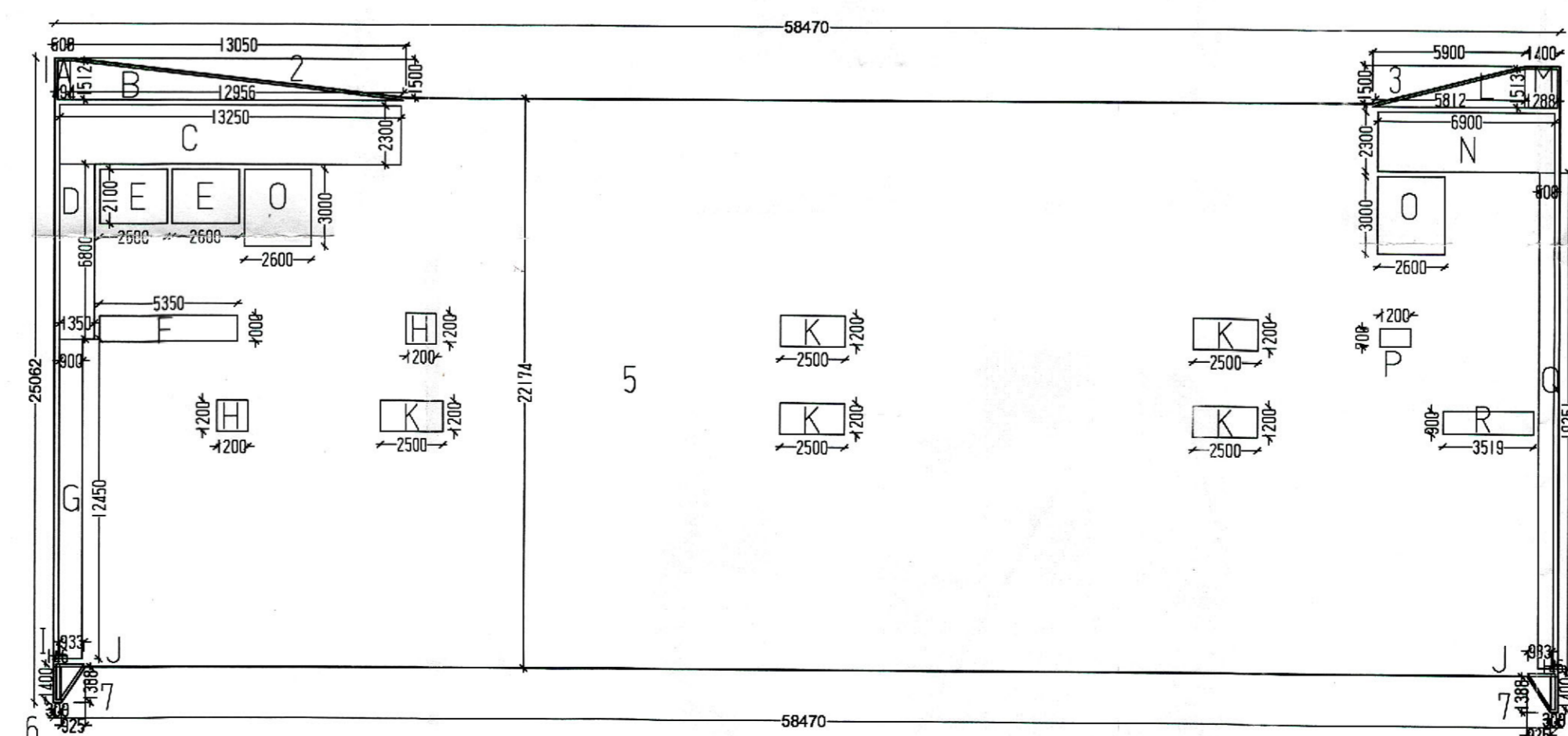
